Since the Committee met in Canberra on 25 September 1967 the Co-ordinator has taken the following action to implement the views expressed by the Committee:-

1. Discussion with Dr. R.W. Greville and Dr. K.W. Edmondson of the Commonwealth Department of Health. The general scope of the Project HA 1 was outlined, and applications to N.H. & M.R.C. which might be integrated in the project were reviewed. It was agreed that the full I.B.P. proposals be submitted to Dr. Greville when in a more advanced stage of planning.

2. Discussion with Dr. S. Langsford in Sydney on the extent of the collaboration of the N.T. Department of Health with the I.B.P. project. This preliminary discussion was followed by more extensive discussions in Darwin with Dr. Langsford and members of his department and also with Mr. H.C.
